Dear *Chief Secretary,*

Please refer to my earlier DO letter of even no. dated 4th June, 2020 regarding TULIP – The Urban Learning Internship Program launched jointly by Ministry of Housing and Urban Affairs (MoHUA) and Ministry of Human Resource Development (MHRD) along with AICTE on 4th June, 2020.

2. TULIP is an internship program which allows fresh graduates to apply for internships in ULBs and Smart Cities for a period ranging between 8 weeks to 1 year. These internships enable them to gain experiential learning, thereby making them market-ready on the one hand and infusing fresh energy in our local governments on the other. The program is a win-win-win for students, cities and industry.

3. TULIP can be extended to the State/UT's Parastatals and other departments related to urban development which may benefit from the infusion of fresh ideas.

4. Along with my DO letter dated 4th June, 2020, I had enclosed copies of a) brochure, b) Guidelines for ULBs/Smart Cities, c) Handbook for ease of implementation by our ULBs/Smart Cities. These documents are available on the Portal : <https://internship/aicte-india.org>.

5. I had requested you to designate a Nodal Officer at State/UT level to coordinate work related to TULIP and share their details (name, designation, phone no. email ID) at tulip-support-mohua@gov.in and cconeat@aicte-india.org. Further, I had requested to advise ULBs/Smart Cities in your State/UT to register at <https://internship.aicte-india.org> and start engaging interns. While all 100 Smart Cities have registered themselves and have started posting their internship requirements, out of around 4,400 ULBs in the country only a handful have done so which is a cause of concern.

6. A few Smart Cities/ULBs have posted a large number of internship requirements for COVID-19 related activities. Other Smart Cities/ULBs have sought interns in different areas such as Health, Town Planning, Finance, Water Resources, Information Technology, Electrical, Civil and Environmental Engineering etc. This clearly reflects the need of such skillsets in municipal/urban governance.

7. In light of the above, I once again request you to treat TULIP as a Resource to engage young graduates in urban field functioning and urge you to get all your ULBs registered at the Portal. Kindly advise them to identify and post their internship requirements at the earliest possible. You may please explore scope of scaling up TULIP to Parastatal agencies/State Financial intermediaries and other organizations/agencies related to Urban Development.

8. I would further request you to send the details of the Nodal Officer at tulip-support-mohua@gov.in and econeat@aicte-india.org at the earliest possible.
