## **MINUTES**

- 1. The matter related to refusal of TIC, Department of Commerce and other members to work out and distribute total workload of department amongst the sanctioned posts allocated to Department of Commerce was discussed at length. The Governing Body members also gave Mr. Praveen Kumar TIC, Commerce a personal hearing. After hearing both Mr. Praveen Kumar & the Principal and going through all the emails exchanged between the Principal and TIC, Commerce, it was unanimously resolved by the Governing Body members to direct Mr. Praveen Kumar to prepare revised/fresh Time Table of his Department within the sanctioned post of faculty of the Commerce Department by working out either tutorial or practical group size, or choice of optional papers (DSE, SEC or GE) as per the "CBCS Guidelines" available on the University website. The soft copy of the same is to be submitted in the College Principal's Office, Central time table committee of Staff Council by 12 noon tomorrow i.e. 26th July along with the soft copy forwarded to the Hon'ble Chairman, GB. It was further resolved that if Mr. Praveen Kumar failed to submit the Time Table within the stipulated time given to him by 12 noon tomorrow i.e. 26th July, 2019 then the GB will make an alternate arrangement to make sure that the Time Table should be prepared as per the CBCS guidelines immediately in the interest of students.
- 2. The written complaint filed by the students of Psychology Department against the Ad-hoc teacher, Dr. (Ms) Pallavi Raj was reported in G.B. The Hon'ble Chairperson & Treasurer, GB met few students of Psychology Department and asked them to give their frank opinion about the said teacher.
